VAWK Appendix 1

We **VAWK** hold personal data about children and families to whom we provide services which may include the name(s) and address(es) of your child/children. We use this data so we are able to support young carers and their families to access appropriate services.

We receive financial support (a grant) from Kent County Council (KCC) Early Intervention Service and as part of the Grant Agreement we are asked to share some of this information with Early Intervention services. The purpose of sharing this information is so KCC are able to know the number of children who receive a service from Kent Young Carers. This information then helps in the planning of services needed in the following year.

We also participate in a local provider forum. This is an opportunity for young carer services and adult carer services to share this information to ensure young carers have a smooth transition into adult services.
